This policy also covers the liabilities which could be incurred by the sponsor, principal investigator and his/her research team, including hired clinical researchers, and the hospital or site where the clinical trial is conducted, pursuant to Art. 61 of Royal Decree Law 1/2015, of 24 July, approving the consolidated text of the Act on guarantees and rational use of medicines and medical devices, and in the terms and risks defined in Art. 9 and Art. 10 of Royal Decree 1090/2015, of 4 December, regulating clinical trials with medicinal products, Medicinal Product Research Ethics Committees and the Spanish Clinical Studies Registry.

3. The guarantee limits established are: minimum of $250,000 \in$ per person undergoing the clinical trial, with a maximum limit of 2,500,000 \in per clinical trial and per year (Art. 10.3 of Royal Decree 1090/2015).

4.
